SUBJECT: RESCIND RESOLUTION 19-31 AND ADOPT RESOLUTION NO. 21-23 AUTHORIZING THE FILING OF AN APPLICATION TO LAFCO TO INITIATE PROCEEDINGS FOR ANNEXATION OF FIRE PROTECTION SERVICES TO THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT.

STAFF RECOMMENDATION:

It is recommended that the City Council:

1. Rescind Resolution 19-31 and adopt Resolution No. 21-23 authorizing the filing of an application to LAFCO to initiate proceedings for annexation of fire protection services to the San Bernardino County Fire Protection District; and
2. Authorize the City Manager to negotiate terms and conditions of annexation with the County and the County Fire District and return to the City Council for approval.

BACKGROUND:

On December 11, 2019, The City of Adelanto City Council voted to approve Resolution 19-31 which authorized application for annexation into the County Fire District and Fire Protection Service Zone 5(FP-5). However, due to pending Ballot Measure U, which if passed would have repealed FP-5 and other additional information which needed to be collected the application was put on hold. Due to Ballot Measure U (which failed) and the amount of time that has elapsed since the approval of Resolution 19-31, the Fire Chief, out of an abundance of caution, has requested that the Resolution 19-31 be Rescinded and that the City Council adopt resolution 21-23.

Annexation into the SBCFPD will transfer the responsibility for all aspects of the fire services, which cost the City \$5,238,184 in FY 2020/2021, to SBCFPD including buildings and equipment. It will also result in the transfer of revenue from the City to SBCFPD with a revenue sharing agreement in place.

In terms of funding, under the annexation approach the City essentially transfers responsibility for fire and EMS service delivery to the SBCFPD. Using the established Local Agency Formation Commission (LAFCO) process, a property tax transfer is accomplished based on the service level agreed upon. The City will then not have any further responsibility for funding fire services. Since costs are less than those needed to operate a contract fire department, the City will be able to preserve General Fund revenues for other City services. SBCFPD will have the obligation for all future costs.

Additionally, the annexation creates the ability for the City to request annexation into a parcel assessment zone, Service Zone FP-5, which would result in a modest parcel assessment to be levied on an annual basis by the County (as the governing board of the District) in the amount of approximately one hundred fifty-seven dollars per parcel per year to fund fire services within the City. This is common practice in the SBCFPD and in the State and would be administered by SBCFPD. Furthermore, the current potential cost savings notwithstanding, the annexation will relieve the City of replacing two existing fire apparatus at a cost of approximately \$1.2 million and deferred maintenance of the fire station in an unknown amount. When complete, the City will have very limited further obligation with regard to fire and emergency medical services within the City. The SBCFPD will have responsibility for all operating costs, capital and equipment, to be paid from a portion of existing City property tax revenues. This means the City will have almost no obligation for fire stations, fire equipment, or the associated costs of maintaining a fire department.

The annexation process is initiated by a resolution adopted by both the City and the SBCFPD in support of an application to LAFCO. The application itself is prepared according to instructions and requirements promulgated by LAFCO.

FISCAL IMPACT:

There are two categories of fiscal impacts to consider.

The first involves the impact to the General Fund budget. Not only is the operating cost a significant savings, there are additional categories of significant savings. The City would no longer be responsible for the purchase and maintenance of all fire trucks, equipment, and facilities. In all, the estimated savings include \$2.0 million in contract savings per year, \$1.2 million in equipment replacement savings, and an unknown amount of deferred maintenance savings.

The second fiscal impact is the fees paid to LAFCO to cover the cost of the annexation process itself. At this time, the exact cost is not known, however, other jurisdictions have completed the process for between \$50,000 and \$70,000.

RESOLUTION NO. 21-23

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ADELANTO, COUNTY OF SAN BERNARDINO, CALIFORNIA, AUTHORIZING THE FILING OF AN APPLICATION TO THE LOCAL AGENCY FORMATION COMMISSION TO INITIATE PROCEEDINGS FOR A SPHERE OF INFLUENCE AMENDMENT (EXPANSION) OF THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT AND REORGANIZATION TO INCLUDE ANNEXATIONS TO THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT, ITS NORTH DESERT SERVICE ZONE, AND SERVICE ZONE FP-5

WHEREAS, the City entered into an agreement with San Bernardino County Fire Protection District ("District") to provide fire protection and emergency medical services on June 13, 2018; and

WHEREAS, the City is currently faced with a significant structural General Fund budget deficit and wishes to reduce the cost to the City's General Fund of providing contract fire services; and

WHEREAS, the City desires to initiate proceedings pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, commencing with Section 56000 of the California Government Code for:

- a) a sphere of influence amendment for the San Bernardino County Fire Protection District; and
- b) a reorganization proposal to include, but not limited to, annexation to the San Bernardino County Fire Protection District and its North Desert Service Zone and Service Zone FP-5; and

WHEREAS, the territory proposed for reorganization is legally inhabited and a description of the boundaries for all actions is attached hereto and by this reference incorporated herein; and

WHEREAS, the proposed reorganization will not conflict with any existing sphere of influence as the proposed change includes an amendment to the San Bernardino County Fire Protection District sphere of influence to accommodate the proposed reorganization; and

WHEREAS, it is desired that the proposed reorganization be subject to the following terms and conditions:

- a) the District shall assume all rights, duties and responsibilities, personal property, contracts, equipment, assets, liabilities, obligations, functions, executory provisions related to fire protection and emergency medical services, except as otherwise outlined in the Conditions of Approval by Local Agency Formation Commission (LAFCO); and

- b) the Plan for Service included with the application outlines the general approach and parameters for delivering fire and emergency medical services to serve the City. The District will assume responsibility for providing sustainable service to the residents and businesses of the City as a condition of annexation and for providing the personnel, facilities, equipment and oversight necessary to do so on an ongoing basis; and
- c) as a function of the reorganization the City shall annex to the District's North Desert Service Zone and Service Zone FP-5 for the purpose of fire protection and emergency medical operations; and
- d) all previously authorized charges, fees, assessments, and/or taxes currently in effect, now levied or collected by the City related to fire protection, including community facilities district shall continue to be levied and collected by the District; and
- e) the standard terms and conditions imposed by the Local Agency Formation Commission upon all proposals or such additional conditions as may be deemed appropriate or necessary by the Local Agency Formation Commission in its consideration; and

WHEREAS, the reasons for the sphere of influence amendment and proposed reorganization are to provide effective, safe and financially sustainable fire protection and emergency medical services to the City of Adelanto.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ADELANTO DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to apply to the Local Agency Formation Commission for San Bernardino County to take proceedings for the sphere of influence review and proposed reorganization as described in the City's application, in the manner provided by the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000.

SECTION 2. The City Manager is authorized to negotiate terms and conditions with San Bernardino County and County Fire regarding fire service and the annexation.

SECTION 3. Certification. The City Clerk of the City of Adelanto shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.








